Considerations when Defining Data Dashboard Requirements	A document from the Arizona Department of Health Services outlining the agency's strategy and guidelines for developing data dashboards. The document outlines their program, staffing requirements, goals, data collection and analysis strategy, and data dashboard workflow, format, style, and monitoring protocols.
COVID-19 Vaccine Solutions Dashboard	A document that describes how Pima County, Arizona, could use its COVID-19 data dashboard to help identify and intervene in areas with low vaccination uptake.
Maricopa County Public Health COVID-19 Stories: Voices of Maricopa County	A website that demonstrates an example of sharing community members' stories.
Massachusetts Department of Public Health Racial Equity Data Road Map: Data as a Tool Towards Ending Structural Racism	This Racial Equity Data Road Map is a tool by the Massachusetts Office of Health Equity used to eliminate structural racism. The guide provides guiding questions, tools, and resources to guide health agency programs to better identify, understand, and act to address racial inequities. It includes step-by-step guidance on collecting and analyzing racial and health equity data and strategically moving data to action.
Pros and Cons of Tableau, PowerBI, and R Shiny	A document from the Washington State Department of Health that compares the pros and cons of Tableau, Power BI, and R Shiny.
WA DOH COVID Dashboard Style Guide	A document from the Washington State Department of Health that outlines the agency's protocols for displaying data on data dashboards. The documents details protocols around data standards, data quality, data validation, dashboard verbiage, dashboard page layout, design, visualization colors, agency-wide visualization standards (maps, decimal places, titles, and more), data suppression, data annotations, and statistic reporting and standards.
